Terminal Bonus, (if declared) Deferred Income: For a policy where all due premiums have been paid, the maturity benefit will be the aggregate of: 1. Sum Assured on Maturity plus 2. Accrued Guaranteed Income and Cash Bonuses (if declared), if not paid earlier plus 3. Interim Survival Benefit(if any) plus 4. Policy Loans	Once the policy has acquired a Surrender Value, you can take a policy loan up to maximum 80% of the surrender value of your policy, subject to the applicable terms and conditions.											
Exclusion	In case of death due to suicide within 12 months from the date of commencement of risk under the policy or from the date of revival of the policy, as applicable ,the nominee or beneficiary of the policyholder shall be entitled to at least 80% of the total premiums paid till the date of death or the surrender value available as on the date of death whichever is higher, provided the policy is in force.											
Free Look-in period	15days from the date of receipt of the original policy document. If you have purchased your Policy through Distance Marketing this period will be 30days.

Premium discontinuance & Paid-up	If You don't pay the due premiums before the expiry of the grace period, your Policy will: 1. Lapse if it has not acquired a Guaranteed Surrender Value (GSV). Once your Policy lapses, all the benefits including the risk cover will cease. 2. Become a reduced paid-up policy if it has acquired a GSV with reduced benefits. Your Sum Assured on Death/Maturity will reduce to Paid-up Sum Assured on Death/Maturity For details on maturity and death benefit of paid-up policy please refer to your policy document.											
Revival	The revival period shall be as specified by the regulations. Currently, the period is five (5) years.											
Surrender	Surrender value payable shall be higher of: Guaranteed Surrender Value(GSV)or Special Surrender Value(SSV) Plus, any accrued survival benefit, if not paid earlier plus interim survival benefit.
